### THIS IS A RELEASE OF LIABILITY... PLEASE READ BEFORE SIGNING

**Note: This form must be read and signed before the participant is allowed to take part in any paintball event.**

IN CONSIDERATION of being permitted to participate in the sport of paintball under the auspices of NORTH AMERICAN RIVER RUNNERS, INC. I acknowledge, appreciate, and agree that

- 1) The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death and, while particular protective equipment and personal discipline will minimize this risk, the possibility of serious injury does exist.
- 2) **I knowingly and freely assume all such risk**, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation.
- 3) I understand that the activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring it to the attention of the nearest official as soon as practical.
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS, NORTH AMERICAN RIVER RUNNERS, INC. (NARR), THE NORTH AMERICAN RIVER RUNNERS FIELDS, the owners and lessors of premises used to conduct the paintball activities, their officers, officials, agents and/or employees (RELEASEES) WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct.
- 5) I understand and agree this RELEASE OF LIABILITY AGREEMENT covers each and every paintball activity and event in which I participate hereafter.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. I CAN READ AND UNDERSTAND THE ENGLISH LANGUAGE.
